

## **DP CLUB MEMBER EXCLUSIVE FREE PARKING PRIVILEGES**

After making designated same-day spending at D · PARK, DP Club Members will be entitled to redeem free parking hours on the same day by presenting (i) an eligible same-day merchant's machine printed receipt issued by the Participating Merchants of D · PARK and the corresponding electronic sales receipt (Credit Card, EPS, Octopus, Apple Pay, Android Pay, Samsung Pay, Tap & Go, WeChat Pay, Alipay); (ii) the same Octopus Card they use to enter and exit the carpark; and (iii) physical or electronic membership card of DP Club.

#### **Parking Privilege 1**

**Mon – Fri** (max. 2 eligible receipts from different merchants)

**Sat, Sun & Public Holidays** (max. 2 eligible receipts from different merchants)

| 1 hour                      | HK\$100 - \$199            |
| 2 hours                     | HK\$200 - \$299            |
| 3 hours                     | HK\$300 - \$399            |
| 4 hours                     | HK\$400 - \$499            |
| 5 hours                     | HK\$500 or above           |

### **Terms and Conditions**

1. Unless otherwise specifically defined, all capitalized terms used herein shall have the same meanings as in the Terms and Conditions of DP Club (the "**DP Club T&C**"). 2. Only a DP Club Member who has (i) met the respective same-day spending requirements of the Net Spending Amount applicable to the above parking privileges; and (ii) successfully registered such Net Spending Amount for earning the corresponding DP Club Points on the same day pursuant to the DP Club T&C, is entitled to enjoy the above parking privileges.
3. Only spending made by electronic payment would be accepted for redeeming the parking privileges. Other modes of payments, including cash and cash coupon, will not be accepted.
4. No parking privilege would be granted to a DP Club Member unless he/she has presented eligible proofs of spending pursuant to the DP Club T&C for registration of the Net Spending Amount and earning of the corresponding DP Club Points. For the avoidance of doubt, the above parking privileges would not be applicable to any spending excluded for the earning of DP Club Points under the DP Club T&C. For further details on such excluded spending, please refer to the DP Club T&C.
5. All proofs of spending will be verified by the staff of D-PARK. Discovery Park Commercial Services Limited ("**DPCSL**") has the right to mark on any eligible proofs of spending presented to DPCSL for registration. The proofs of spending marked by DPCSL cannot be used for redeeming further parking privileges in D-PARK.
6. DPCSL will not accept any reprinted receipts, handwritten receipts and photocopies of receipts as proofs

- of spending.
7. DPCSL may in its sole discretion reject any proofs of spending without any need for explanation if DPCSL is of the view that:
    - (a) the proof is invalid or forged;
    - (b) the receipt is not issued to support a genuine transaction;
    - (c) the Member is not a party to the relevant transaction; or
    - (d) the proof is on any other grounds not acceptable to DPCSL in its entire and absolute discretion.
  8. The staff of DPCSL is entitled to assume without further proof that the bearer of the physical or electronic membership card of DP Club is the member named thereon or has the authority to act on behalf of the member.
  9. The above parking privileges cannot be enjoyed at the same time.
  10. The parking privileges are applicable only to private cars that enter the carpark according to DPCSL's time records, but are inapplicable to any commercial vehicles (e.g. taxis and vans).
  11. The parking privilege cannot be split, transferred, refunded or exchanged for cash, coupons or vouchers.
  12. Each DP Club Member can only redeem the parking privilege once per visit.
  13. The above parking privileges cannot be redeemed once the parking fee is settled.
  14. Regular hourly rates shall apply for every additional hour parked beyond the redeemed free parking hour(s). Unless stated otherwise, a partial hour is considered a full hour.
  15. Unless otherwise specified, the above parking privileges cannot be used in conjunction with any other parking offers.
  16. All staff of DPCSL, their family members, and staff of D · PARK's tenants are not entitled to the above parking privileges.
  17. DPCSL has the right to amend these Terms and Conditions at any time without any prior notice.
  18. DPCSL has the absolute right to terminate or suspend the above parking privilege without prior notice.
  19. DPCSL has the right to interpret these Terms and Conditions. In case of any disputes, the decision of DPCSL shall be final and binding on all parties concerned.
  20. All other terms and conditions of DP Club shall apply.
  21. The Chinese version of these Terms and Conditions is for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version shall prevail.
